In consideration of, and as inducement to the acceptance of my application for training classes or membership at the Regina Kennel and Obedience Club, I agree to indemnify and hold harmless the Club, their employees, members, instructors, assistant instructors and agents from any and all claims, actions, cause of action, demand, damages, suit, costs, charges whether legal or equitable, of every nature and kind and howsoever arising and whether known or unknown by any person, including but not limited to any member of my family or any other person accompanying me to any training session or function or the Club, whether on Club property or elsewhere.

## **Membership Definitions and Pricing**

(As defined by the Regina Kennel and Obedience Club By-Laws)

**Note: All Classes of membership must complete an annual renewal form!**

### **Associate Member \$40.00 and Associate Family Member \$60.00**

1. Eighteen (18) years of age or older with the right to vote, but not hold office.
2. Associate membership shall be for one year from date of application.

### **Single Adult Member \$40.00**

1. Eighteen (18) years or older who has completed one year as an Associate Member, a Family Child or a Young Adult, shall be a Member in Good Standing with the right to vote and hold office.

### **Family Member \$60.00**

1. One or two adults from the same household, both over the age of eighteen (18), who have completed one year as an Associate member, each adult shall be a Member in Good Standing with the right to vote and hold office.
2. Children of the Family Members, under the age of eighteen (18), may be included in a Family Membership, but shall not have the right to vote or hold office, shall not have unsupervised access to the building, or act as trainers for any class. May transfer to a Single Adult membership on their eighteenth (18<sup>th</sup>) birthday.

### **Young Adult Member \$20.00**

1. An individual between the ages of fourteen (14) and eighteen (18) who has completed one years membership shall be a Member in Good Standing but does not have the right to vote, hold office, unsupervised access to the building, or cannot be a trainer for any classes. May transfer to a Single Adult membership on their eighteenth (18<sup>th</sup>) birthday.

### **Life Member**

1. Life membership shall be granted to each individual member who has maintained twenty (20) continuous years of Adult membership shall be a Member in Good Standing with the right to vote and hold office.
